Background summary

The capacity to form romantic relationships and the sexual health of adolescents in the Netherlands are compromised by several factors, such as young age of first intercourse and adolescent depression. Several thresholds like costs and trust prevent adolescents to seek help for their sexual problems. To overcome these thresholds, brief sex counselling has been developed. It has been used successively since 2006 within the Rotterdam Public Health Service (GGD Rotterdam-Rijnmond), but there is lack of information about the effectiveness and cost-effectiveness of brief sex counselling.
